

DELHI UNIVERSITY TEACHERS WELFARE FUND (DUTWF)

The Academic Council, University of Delhi, vide its Resolution No. 262, dated 22nd February 1975 instituted a Welfare Fund called "The Delhi University Teachers Welfare Fund" for the teachers of the University and its affiliated and constituent colleges/institutions with effect from March 1975.

Aim and Objective

The objects for which the fund has been established shall be:

To provide relief in case of distress or hardship amongst the teachers of the University and Colleges/Institutions and to render such financial assistance or relief as may be deemed necessary to the widows and dependents of deceased teachers of the University and colleges. The benefit under this rule shall also be available to widows and dependents of the teachers of the University and the Colleges/Institutions, who are members and are subscribing to the Teachers Welfare Fund.

To provide sickness or maternity benefits in case of special hardship.

Managing Committee constituted as follows for the management and administration of the Fund:

- I. Patron - Vice-Chancellor of the University
- II. President - Pro-Vice Chancellor (Ex-Officio)
- III. Registrar of the University (Ex-Officio)
- IV. Finance Officer of the University (Ex-Officio)
- V. Three Deans of Faculties to be nominated by the Academic Council
- VI. Three Principals of colleges (one of whom shall be a woman Principal) to be nominated by the Academic Council
- VII. Two members of the Executive Council to be nominated by it, who are not Deans or Principals
- VIII. Four teachers to be nominated by the Academic Council from among the elected teacher members on the Academic Council.

The Managing Committee shall appoint the Secretary and Treasurer of the Committee.

Initially, monthly contribution from teachers started with Rs. 2/- towards DU Teachers Welfare Fund. Later on it was enhanced to Rs. 5/- per month vide Managing Committee meeting held on 8th January 1987. Again, the executive council vide its resolution No. 141(3) dated 22nd February 1990, has raised the rate of contribution from Rs. 5 to Rs. 10/- per month per teacher. The monthly subscription again got raised from Rs. 10/- to Rs. 20 per month vide decision taken in the Managing Committee meeting held on 3rd July 1998.

The present monthly subscription is Rs. 50/- per month which was increased from Rs. 20/- to Rs. 50/- in managing committee meeting held on 16.01.2004.

Criteria for Financial Assistance

Financial Assistance given to its members by Teachers Welfare Fund are as follows:

Medical Assistance:

- I. Upto 1.5 Lakh only
- II. 70% of the bills not reimbursed by the Colleges/Departments/ University.

In case of Member's death:

Age group	Financial Assistance
1. 50 Years and above	Upto Rs. 2,40,000/-
2. Between 40-50 Years	Upto Rs. 2,80,000/-
3. Below 40 Years	Upto Rs. 3,20,000/-

Medical Hardship:

In case of Medical Hardship an assistance up to Rs. 3,00,000/- should be provided and it should be restricted to the member and his/her spouse only.

Corpus

Corpus as on 31.03.2018 is Rs. 8,48,83,064.92/- (Rs. 4,16,71,256.92/- in Saving Bank Account and Rs, 4,32,11,808/- in the form of FDRs).
