PROFESSOR NAQVI MEMORIAL SCHOLARSHIP!

There shall be one scholarship called 'Professor Naqvi Memo dal Merit Scholarship' of the value of Rs. 150/- p.m. payable out of he annual income accruing from the interest on the 'Professor K.A. Naqvi Memorial Fund-II' of Rs. 14,000/- endowed to the University by Prof. Naqvi's Friends in Canada.

- 2. The scholarship shall be awarded to a deserving student of M.A. Part-II course in Economics enrolled at the Delhi School of Economics.
- 3. The Scholarship shall be awarded on the recommendation of the Scholarships Committee of the Department of Economics which will follow the same procedure of selection as is followed for the award of other merit-based scholarships with the Department.
- 4. The scholarship shall be awarded every year and shall be tenable for 10 months only from 1st July of an academic year to 30th April of the same academic year (next calender year).
- 5. If it should appear at any time to the Head of the Department of Economics that a scholar has failed to make satisfactory progress or has been guilty of gross misconduct, after due warning in writing his scholarship may be suspended or withdrawn on the specific recommendation of the Scholarships Committee of the Department of Economics.
- 6. No student shall be eligible for this scholarship if he/she already holds a scholarship awarded by Delhi University or any other University or the Central Government or any State Government or a Private Body.
- 7. In case a scholar under this endowment accepts any other scholar ships/financial assistance from any other source, he/she shall be required to surrender this scholar ship and shall be required to refund the amount received by him/her on account of this scholar ship from the date he/she accepts the other scholar ship/financial assistance.
- 8. In case a scholar discontinues the studies without valid reasons, he shall be required to refund the amount received by him/her on account of the scholar ship.
- 9. In case a scholarship falls vacant during the pendancy of the same, it may be reawarded to another student on the recommendations of the Department Scholarships Committee for the k residuary period.
 - 10. Any amount accruing from interest from the endowment and not spent in any year shall be added to the corpus of the endowment fund.
 - 11. The payment of the scholarship amount will be made to the scholar through the Head of the Department of Economics on the presentation of a bill and a certificate to the effect that during the period covered in the Bill, the scholar was not in roceipt of any other scholarship or financial assistance from any other source and also that he was regular in attendance and his progress at studies was satisfactory.
